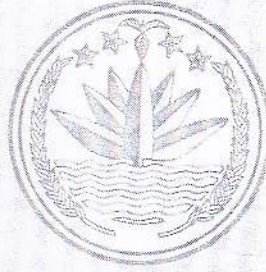

### Contract Agreement (Form e-PG3 – 8)

THIS AGREEMENT made the 25 day of January, 2018 between Dr.Khurshid Zabin Hossain Taufique ,Director, Urban Development Directorate (UDD) 82, Segunbagicha, Dhaka-1000 (hereinafter called "the PE") of the one part and Afifa Easmin, Proprietor of Archimaze, Room #5 (5<sup>th</sup> Floor), AK Complex, 19, Green Road, Dhaka- (hereinafter called "the Supplier") of the other part:

WHEREAS the PE invited Tenders for certain goods and related services, viz, "Collection and Supply of Mouza Map the area of 841.73 sq.km.
