Contract Agreement (Form PG2 - 6)

THIS AGREEMENT made the 01 day of March 2018 between Dr. Khurshid Zabin Hossain Taufique, Director, Urban Development Directorate (UDD), 82, Segunbagicha, Dhaka-1000, (hereinafter called "the Procuring Entity") of the one part and Md. Arif Khan (Arob), Proprietor of Khan Rent-A-Car, Address: 35/2/1, Brammanchiron, Golapbag, Dhaka-1203 (hereinafter called "the Supplier") of the other part:

WHEREAS the Procuring Entity invited Tenders for certain goods and related services, viz. "Supply of 1 (One) Micro-bus monthly rent basis for route UDD Head Office, Segunbagicha, Dhaka to Bhasantek, via Azimpur, Kalabagan, Asadgate, Kallyanpur, Technical, Mirpur-1, Mirpur-10, Mirpur 14, Bhasantek and vice versa. Contract Period/Supply Duration: 4 Months (Contract Period may be extended if the both party agreed in Terms and Conditions of Contract)" and has accepted the Tender by the Supplier for the supply of those goods and related services in the sum of Taka 3,69,996 (Taka Three Lakh Sixty Nine Thousand Nine Hundred Ninety Six only) (hereinafter called "the Contract Price") and which will be paid monthly basis in Taka 92,499/- (Taka Ninety Eight Thousand Four Hundred Ninety Nine only) per month.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.

2. The following documents forming the Contract shall be in the following order of precedence, namely :
 - (a) the signed Form of Contract Agreement;
 - (b) the Notification of Award
 - (c) The Tender and the appendices to the Tender
 - (d) Conditions of Contract;
 - (e) Technical Specifications;
 - (f) Price Schedules and Schedule of Requirements and;
 - (g) other document, if any
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and related services and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and related services, the Contract Price may become payable under the provisions of the Contract on monthly basis.
5. Extra mileage (if necessary) during office hour will be paid BDT 15 per Kilo Meter.
6. The Contract Agreement may be extended with the negotiation of the two parties complying with the existing regulation.








