THIS AGREEMENT made the 27/05/2018 between Director, Urban Development Directorate (UDD), Ministry of Housing and Public Works, 82, Segunbagicha, Dhaka, Bangladesh (hereinafter called "the PE") of the one part and TILLER Address: 11/B, 1/18 Mirpur, Pallabi Dhaka-1216 (hereinafter called "the Supplier") of the other part:

WHERE AS the PE invited Tenders for certain goods and related services, viz, Supply of goods and related services for Purchase and Collection of High Resolution Image by UAV or 3D Laser Scanner and processing, 3D digitizing, editing, database preparation and geo-referencing, printing etc. for the urban area of the project. For UDD against Contract No: UDD/2017-18/PKCP/5002-11 (High resolution Image), Scanner Date: 17-May-2018 and has accepted a Tender by the Supplier for the supply of those goods and related services in the sum of Tk. 33,04,650.000 (Taka THIRTY-THREE LAKH FOUR THOUSAND SIX HUNDRED AND FIFTY) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSED AS FOLLOWS:

 - (g) Price Schedules and Schedule of Requirements and;
 - (h) Other document including correspondences listed in the PCC forming part of the Contract






